Also enclosed, you will find the following items necessary to file your Other Tobacco Products Tax Return and/or Cigarette Tax Returns.

Other Tobacco Products licensed distributors will find the **Tobacco Products Tax Guidelines And Rules (Form TT-22)** enclosed. We recommend that you read the guidelines carefully.



Effective July 1, 2016, you are required to electronically file Form TT-8 and submit payment using the Department's online **eForms** option available at [www.tax.virginia.gov](http://www.tax.virginia.gov). Payments can be remitted by direct debit when filing the form or by an ACH credit transaction arranged through your financial institution. All returns are due on the 20<sup>th</sup> for the preceding month.

If you are unable to meet the electronic filing requirements, you must request a temporary waiver. Visit [www.tax.virginia.gov](http://www.tax.virginia.gov) for more information.

Permitted Cigarette Stamping Agents will find the following items enclosed:

- **Order for Virginia Cigarette Tax Stamps (Form TT-2)**. This form is used to order the tax stamps that are affixed to packs of cigarettes.
- **Monthly Report of Cigarette Stamping Agent (Form TT-13)** or **Monthly Report of Non-Resident Cigarette Stamping Agent (Form TT-14)**.
